MEDAL OF VALOR AWARD

This decoration is awarded to a member of the Department who, while serving in his official capacity, distinguishes himself conspicuously by heroic action, above and beyond the call of duty. Each recommendation for the Medal of Valor Award must incontestably prove that the self-sacrifice of personal bravery involved conspicuous risk of life, the omission of which could not justly cause censure. A police officer shall be eligible for this award if he is killed while performing police duties, provided that the death of the officer was not caused primarily by his own negligence or misconduct, and further provided that the actions of the officer immediately preceding his death do not reflect discredit upon himself or the Department.

WOUNDED IN SERVICE AWARD

This award is presented to a member of the Department who, while acting in the performance of duty, is wounded by an armed adversary, and such wound requires medical attention and absence from regular duty for any length of time. Such wound must become part of such member's record. Traffic accidents or other mishaps are not within the criteria for this award; however, officers killed in the line of duty are eligible for this award providing that the circumstances surrounding the incident did not reflect unfavorably upon the Department or the employee.
